Passes must be collected in person by the applicant from the Lloyd's Camera Room which is located on the Concourse Level of the Lloyd's Building and is open daily Monday to Friday from 8.00am – 5.00pm. To collect a pass, the applicant must produce their passport or photo driving license which must display the same name as on the form. Please allow five working days to create the pass. A temporary pass may be issued pending consideration of any application. Retention of the pass is subject to Lloyd's acceptance of the applicant's Annual Subscriber application.

Any person who wishes to be admitted to the premises of the Society of Lloyd's to conduct insurance business such as, but not limited to, the underwriting, broking or placing of risks, reinsuring such contracts or determining or negotiating claims must be registered as an Annual Subscriber. - 1 That I shall be bound by the Lloyd's Acts 1871 to 1982, the byelaws, regulations and directions made there under and all requirements and conditions imposed and directions made under any such byelaw or regulation, all as amended from time to time;
- 2 I understand that the burden is on me to demonstrate to the Council that I am suitable to be registered;
- In the event that this application is refused or in the event that my name is subsequently removed from the register of Annual Subscribers for whatever reason, I agree that I shall not prior to exhausting my rights of review or appeal as provided for by the Council of Lloyd's seek to exercise any other rights of review, appeal or action; and
- 4 That the information that I have given in this form is to the best of my knowledge and belief complete and accurate.

In the event that I am registered as an Annual Subscriber, I understand and agree that:

- 1 I must produce my Annual Subscriber pass when entering Lloyd's premises. The pass is personal to me and must not be lent, assigned or transferred to any other person. Any loss should be reported immediately to the Camera Room;
- 2 I am required to conform to the Market standards of dress and behavior;
- I must ensure that myself and any other person that I bring into Lloyd's premises must comply with the current regulations and adhere to the emergency procedures;
- 4 Smoking and the consumption of food and drink are not permitted in the Room;
- Lloyd's may at any time remove my name from the Register (and thereby require the return of my pass) if in the opinion of Lloyd's I am no longer suitable to be an Annual Subscriber or where Lloyd's considers that to be necessary to protect the interest of the Society;
