We have been informed by the NAIC that they have billed an additional amount of \$250 which will need to be billed to each Lloyd's syndicate listed at any time during 2009 (i.e.: if you have already de-listed since 1 January 2009 it is still payable). This includes sub or incidental syndicates, where applicable. This additional amount of \$250 per syndicate is necessary for the NAIC to correct an internal billing error that resulted in an understated amount on the annual filing fee invoice submitted in February 2009.

On December 7 2008, the 2009 NAIC budget was adopted by its membership and released to the public. The budget called for a specific increase of \$250 in the annual filing fees. Regrettably, the annual filing fee invoices which the NAIC produced still reflect the incorrect prior year amount of \$4,000 rather than the \$4,250, as the budget intended.

I enclose for your records the invoice(s) sent to us by the IID for each listed syndicate managed by your agency. **Please do not settle the invoice directly with the NAIC**. Settlement and Trust Fund Operations (STFO) will be paying this fee on behalf of syndicates and you should make sure that you have returned the necessary form by 5.00 p.m. on Tuesday 23 June 2009. I enclose a copy of the form (at Appendix 1).

A hard copy of the letter from the NAIC will also be sent to all managing agents.
