As the market has previously been advised, the system used for US Situs Trust Fund Regulatory Reporting has been redeveloped for use from quarter 1 2010 (the new Canadian system will be used from Q2 2010 onwards). This is because the old systems are on a platform where Microsoft will soon withdraw support. These systems provide the reporting packs to enable Lloyd's to comply with the filing requirements of the US regulator (and the Canadian Regulator). There are no consequential changes to the returns which are filed or the work which has to be carried preparing or checking the data.

The new systems will be web-based but the basic functionality of the systems remains largely unchanged.

In order for the market to have the opportunity to see the new systems before go-live, workshops are being run on 18 and 19 March 2010 (see attached form for full details of times and venue). These are aimed at those people within the managing agency who complete the electronic packs. They will provide an overview of what the system will look like and how it will operate.

Additionally we will be running a series of hands-on practical sessions on 22, 23 and 24 March (again details of times are on the attached forms). At these sessions agents will be able to come to Lloyd's and use a test version of the system for themselves.
