1 Introduction

Starting with the 2025 year of account, Lloyd's will no longer republish the Auction Rules, Auction Guide, or the Capacity Offer Rules on an annual basis. Instead, these documents will be hosted on the Auctions page of the Lloyd's website and will no longer include any references to specific key dates. All key dates relevant to these documents will be consolidated in this document, which will be updated annually to reflect the applicable year of account.

If any substantive changes are made to the Auction Rules, the Auction Guide, or the Capacity Offer Rules in the future, they will be outlined in a corresponding document for the specific year of account.

They key dates for the 2025 year of account can be found in Annex 1 below.
