What are the Market Charity Awards?

Lloyd's Market Charity Awards are donations to charities supported by individuals from across the Lloyd's market. The awards are run by Lloyd's Charities Trust, a grant making charity which provides charitable donations on behalf of the Lloyd's market.

Donations are given to charities supported by individuals working in the market in recognition of their fundraising and voluntary work, and to charities that have given invaluable support to those in the market whose lives have been affected by difficult circumstances.

In 2021 donations of up to £25,000 will be awarded to charities in direct response to the significant funding gap that they are facing due to the impact of COVID-19.

Who can apply?

Applicants must be a permanent employee working in the Lloyd's market (employed by managing or members' agents or brokers) on the date that the application is made and, if approved, when the award is made on 1 September 2021.

Applicants need to demonstrate direct and sustained personal engagement with their nominated charity during the past 12 months, for example as a volunteer, fundraiser, trustee or beneficiary of services provided.

In contrast to previous years anyone in the market may apply, regardless of if/when you previously won a Lloyd's Market Charity Award. The size of the donation made will be dependent upon the size of the charity applied for and their ability to manage the donation.

Which charities are eligible?

For the purposes of these awards, the trustees will be particularly looking for applications on behalf of:

- Charities or Community Interest Companies (CICs) that benefit from the active involvement of a person or people working within the Lloyd's market;
- Charities that have supported the applicant during difficult times; or
- Smaller, local charities who might struggle to receive funding.

The trustees will not make these awards to:

- Organisations that are not registered charities, or non-UK registered charities (except at the occasional discretion of trustees);
- Political parties or lobbying organisations;
- Grant-making bodies to make grants on our behalf;
- The promotion of religion or other beliefs;
- Individuals, including student grants, bursaries, medical costs or financial assistance;
- Applications towards the personal expenses of individuals participating in fundraising events, such as overseas treks, entry fees, sponsorship or any other costs associated with fundraising activities; and

- Organisations whose objectives might be deemed to be detrimental to the objectives of the Lloyd's market.

How are the applications assessed?

Applications will be reviewed by the trustees of Lloyd's Charities Trust in August – trustees are drawn from both inside and outside the Lloyd's market. You will be informed whether your application has been successful on 1 September 2021.

Decisions regarding eligibility of applicants or beneficiaries, or interpretation of any of the other rules of the Scheme will be at the discretion of the trustees. Trustees will be looking for applications which meet one or more of the criteria above and will seek to make awards to reflect the diversity of the applications and the market itself. The trustees' decision is final.

Completing the form

Please provide details of your involvement with your chosen charity, particularly during the past 12 months (e.g. volunteering frequency, role, amount raised or other personal involvement) and why you would like an Award made to them. Where your involvement with the charity has been as part of a team or group, please make clear your specific contributions to the activities. Where possible, please provide details of how the money might be used by the charity.

Please note that information entered will be **automatically saved** should you wish to complete and submit your application form at a later stage. However, if you are on a public or shared computer, we recommend that you complete and submit your form in a single session to maintain the security of any sensitive information. You will not be able to download or print a copy of the completed form, so you may wish to save key data into a separate document for your records.
