Applications for the Lloyd's Market Charity Awards are now open!

The Lloyd's Market Charity Awards recognise individuals across the Lloyd's corporation and Lloyd's market who have made a significant contribution to charity through volunteering and fundraising and/or have been supported through hard times through the work of the charity. The Lloyd's of London Foundation recognises these amazing individuals in the Lloyd's market and corporation through an unrestricted donation to their supported charity.

In 2024, Lloyd's of London Foundation will be giving out eight awards to individuals who have gone above and beyond for a charity they care about and/or have been supported by a charity. The prize given will be a donation between £5,000 to £20,000 made to the charity.

Applications close on **4 October** and winners will be notified after that date.

Eligibility of applicant

- Permanent or fixed-term employees working in the Lloyd's market and employed by:
 - Lloyd's Corporation
 - Managing or members' agent
 - Lloyd's registered broker
 - Coverholder
- Applicants must be employed by one of the above on the date that the application and award is made.
- Applicants need to demonstrate direct and sustained personal engagement with their nominated charity during the past 12 months, for example as a volunteer, fundraiser, trustee, or beneficiary of services provided.
- Individuals who won a Lloyd's Market Charity Award in 2023 will not be eligible.
- You can nominate someone else to receive an award to recognise their volunteering or fundraising efforts in the last 12 months.



- We do not except applications from people who work for a charity unless you are nominating someone from the Lloyd's market.

Eligibility of your supported charity

We will be looking for applications from individuals who have supported:

- Charities or Community Interest Companies (CICs) that benefit from the active involvement of a person or people working within the Lloyd's market
- Charities that have supported the applicant during difficult times
- Smaller, local charities who might struggle to receive funding

Applications which support the following organisations or causes will not be eligible:

- Organisations that are not registered charities
- Political parties or lobbying organisations
- Grant-making bodies
- Organisations whose objectives might be deemed to be detrimental to the objectives of the Lloyd's Market
- Organisations whose objectives are to promote religion or other beliefs
- Organisations whose primary function is as a school, college, or university (although registered as a charity)
- Individual crowdfunding for personal causes such as student grants, medical costs, or financial assistance
- Applications towards the personal expenses of individuals participating in fundraising events such as overseas treks, entry fees, sponsorship or any other costs associated with fundraising activities
- Organisations with an income of more than £10 million gross

Application form guidance

Our application form is a Microsoft form which can be accessed [here](#). The form is split into four sections and should take around 15 minutes to complete:

Section 1: Your details (approx. 1 min to complete)

This section asks for your details (or the details of the nominee) including, full name, company name, country you/they are based in and email address.

Section 2: Charity details (approx. 5 mins to complete)

This section asks for the charity details including the charity's name, country of operation, charity registration number, summary of charitable aims and objectives and how the charity might use the funds (if known).



Section 3: Your involvement (approx. 10 mins to complete)

This section is the main part of the application form and will take you the most amount of time to complete (approx. 10 minutes). It asks you to detail your involvement with the charity, impact you've had by detailing any personal successes and achievements, how the charity has supported you, friends, or family members if applicable, and the number of hours approximately volunteered or fundraised in the last 12 months if applicable. If you are nominating someone, please complete from their perspective.

Section 4: Additional questions (approx. 1 min to complete)

This section asks a few questions to ensure you, or your nominee is eligible for an award and to inform our marketing strategy. The questions include whether you/they have received an award in the past and in what year, how you heard about the awards and if you can provide quotes and images for use in our internal and external communications.

How will your application be reviewed

- Applications will be longlisted by the Global Community Engagement team and reviewed by Lloyd's of London Foundation's trustee selection panel.
- Decisions regarding eligibility of applicants or beneficiaries, or interpretation of any of the other rules of the awards will be at the discretion of the trustees.
- Trustees will seek to make awards to reflect the diversity of the applications and the market itself.
- The trustees' decision is final.
- Winners will be announced in October and invited to a celebration event.
